Q. Issue of handing over the repairs. A. The reality is that many, many even most are in serious financial condition. Many many of them are drawing on their endowment funds to operate year to year. Many are facing immediate challenges around their existence. Routine challenge is how can we cut our responsibility as diocese because we cannot meet the financial commitments we already made. All of us are doing what we can to face the challenges and to move forward. Not realistic for SPC or any other to hope or to request that the diocese pay for the renovation. We need to pull together and work together as a community. Not as simple as to say the diocese is now responsible for any commitments we need to make. Q. Few points made. Should we hand over the church to the business office. Sell? Theological study that the population of Canada 100,000 per church. The Bishop can turnaround and say we were poor stewards. Therefore I will close the place down. Diocese still owes five million dollars re: court costs. We need to fix the roof. Which is more credible Renew or Project Jericho. Urge everyone to search in their heart. We can still do the renovation but it will take longer. We must have the washrooms to service the people. A. Not solved today. Today we hear the project and support and encourage. Eliminate one project for another will not be the answer. Appreciate all comments but these are bigger issues. Q. Gender neutral washroom? One instead of two. A. The program is 3-4 years old. There is a universal washroom included in the plans now. Worth a thought. Q. Is SPC comfortable with a gender neutral washroom? Similar to the washroom in the Cathedral? A. These are washrooms that accommodate more than one person.
